

#### A BLUEPRINT FOR CHANGE

- Elimination of blatant racism in the state and city departments.
- 2. The appointment of a Black Commissioner

- Black block warden where the prison population exceeds 50%
- Increase in the State budget for the corrections department.
- Intense recruiting of Blacks for jobs in the department.
- Rehire the Black narcotic correction officers that were thrown out under the guise of the so-called budget cut. As with many other Black people under the right wing bureaucracy, these officers can be transferred into the penal system.
- 7. The upgrading of jobs and salary.
- Study programs for officers in the social sciences with Black Studies required for Black and White officers.
- 9. The treatment of all inmates with human dignity and concern.
- Better housing and health conditions for each inmate.
- 11. Black officers to serve on the inmate disciplinary board within each institution.
- 12. The Black Social Worker to go into the institutions to prepare the Black inmate to maintain his legitimate place in his family.
- 13.1mplementing the findings of the Black social worker.
